SUPPORTING DOCUMENTS REQUIRED FOR THE INCOME STATEMENT

- Earnings of the previous month showing cumulative income and holiday pay (separately, if possible)
- If no cumulative data can be provided (new employment), an estimate of future monthly income must be submitted
- Copies of decisions on daily allowance
- Certificate of studies
- Copy of agreement or receipt of child support/maintenance paid or received in respect of every individual child
- Receipts of any other income affecting the fee
- Report on business income: the latest financial statement data. If the data has changed, submit the latest confirmed income statement and balance sheet. Estimated income data in case of new business

The guardian must apply for the potential fee exemption or fee reduction when the school year has begun. If the family's income changes after the decision has been made or if the family grows in size, the City of Turku Education Division must be notified. Fee reductions and fee exemptions that have been granted on the basis of false information may be adjusted retroactively.

The decision on fee reduction by 25 per cent or fee exemption can be made starting from the beginning of the month when the application and its supporting documents have been received by the City of Turku Education Division. The decision remains in force no longer than until the end of the school year in question.

The size of the family refers to persons living in shared household married or in a marriage-like relationship and their minors living in the same household. If necessary, the data will be verified from the population registry.

For the purposes of fee reduction or fee exemption, the income taken into consideration includes the taxable earned income and capital income as well as non-taxable income of a parent or other guardian living in the same household and the person living with him or her in a shared household married or in a married-like relationship.

The following items will not be considered income for calculation purposes: child allowance, disability allowance pursuant the Disability Benefits Act (570/2007) children increment pursuant the National Pension Act (568/2007), housing subsidy, reimbursement of the cost of medical care and examinations paid under accident insurance, conscript's allowance, supplement for war veterans, study grant, adult education allowance, housing subsidy paid on top of student grant, activity allowance and travel allowance paid in the form of basic social assistance, maintenance allowance pursuant the Act on the Rehabilitation Benefits and Rehabilitation Allowance Granted by the Social Insurance Institution (566/2005), travel allowance pursuant the Act on Public Employment and Business Service (916/2012), stipends given for studies and other such assistance, compensation for the cost of family care or child home care allowance.

The following items are deducted from income for calculation purposes: child support paid; other similar costs arising from factual family circumstances; and other monetary benefits payable under annuity contract made for a fixed term or for life.
